Sub: - Submission of "Joint Option Form" under, Para 11(3) and Para 11(4) of EPS, 1995 in accordance to the directions given by Hon'ble Supreme Court, vide Order dated. 4th November 2022.

- Employees Provident Fund Organization (EPFO) had issued instructions in compliance of the Orders of the Hon'ble Supreme Court judgement dated. 04.11.2022 vide Circular no. Pension/2022/54877/15149 dated. 29/12/2022 and Corrigendum vide Circular no. Pension/2022/54877/15238 dated. 05/01/2023.
- 2. As per EPFO circular no. Pension/2022/54877/15149 dated. 29.12.2022; Employees who attained the age of 58 years prior to 1st September 2014 without exercising any option under Para 11(3) of the pre-amendment scheme have already exited from the membership. Therefore, they would not be entitled to the benefits of this judgement.
- 3. As per available information, no ex-employee of BELOP who had exited the EPS'95 before 01.09.2014 is covered under the provisions / conditions stipulated in the said EPFO Circulars. However, it is hereby informed that if any superannuated / retired employees of BELOP who are meeting the criteria specified in EPFO Circulars, if they so desire, may submit their option to the concerned RPFC of EPFO (from where they are drawing Pension under EPS, 1995) as per the procedure along with the supporting documents as indicated as para 6 & 7 of the EPFO Circular dated. 29/12/2022 read with Corrigendum dated. 05/01/2023.
- 4. Employees currently on rolls / Ex-Employees of the Company who are/were members of the EPS'95 Scheme as on 1st September 2014 and are willing to exercise contribution on actual salary in Pension fund under EPS'95 may exercise the 'Joint Option' in the Format at <u>Annexure-A</u> to get the benefits of pension on actual salary as directed by the Hon'ble Supreme Court.

Disclaimer: EPFO guidelines/circular for submission of Joint Option Form as specified above are still awaited. This circular is being issued for implementation of said judgement only to adhere to the timeline and is subject to any ratification(s)/guideline(s) that may be issued by EPFO from time to time. Therefore, mere submission of the Joint Option Form by Employees on rolls/Ex-Employees does not confer any right on them to receive or any obligation on BELOP to pay higher pension. The Joint Option Form as referred above is subject to change / modification based on EPFO instruction, if any.

Employees on rolls / Ex-Employees who are not required to submit this Joint Option Form are:

 Those who have joined on or after 1st September 2014 and / or not a member of EPS'95 in previous organization(s);

 Those who have joined prior to 1st September 2014 and not a member of EPS'95. The option from in triplicate duly signed in original (hard copies) shall be submitted to HR dept for forwarding to respective PF Office for further action.

In case of Ex-Employees, the Option Form will be made available in BELOP website (www.belop-inida.in) w.e.f. 09.02.2023 which can be downloaded and filled in triplicate duly signed in original (hard copies) shall be submitted to HR Dept.

Note:-

- a) The Joint Option Form shall be subject to acceptance by EPFO as per rules. In case, EPFO issues specific format on a later date, Employees / Ex-Employees have to resubmit in that specified format.
- b) Employees/Ex-Employees are liable to pay the required differential amount on account of opting Joint Option for higher pension under EPS'95.
- c) Guidelines & methodology for submission of joint declaration and remittance of contribution along with interest is still awaited from EPFO.
- d) The option exercised is irrevocable at later date and no change of option shall be entertained under any circumstances.
- e) The Joint Option Form duly filled in every manner should be submitted by concerned Employee/Ex-Employee to the HR Dept by 20.02.2023.
- f) Every Employee / Ex-Employee who joined BELOP from any other organization in which he/she was member of EPS'95 scheme should fill **Annexure-B**.
- g) Every Employee / Ex-Employee who joined BELOP from any other organization in which he/she was member of EPS'95 scheme should add their service of the previous organization in current EPS number by filling Form 13 at Annexure-C.
- h) These instructions are subject to directions/instructions of EPFO and/or decision of court of law (if any) issued from time to time in this regard.

Sub: Joint Option under the erstwhile Para 11 (3) and Para 11 (4) of EPS-1995, based upon the Hon'ble Supreme Court's Judgment dated 04.11.2022 in SLP (C) No. 8659-8659 of 2019.

Reference is invited towards Para 43 and Para 44 (ii) & (iv) of the aforesaid order dated 4th November 2022 of Hon'ble Supreme Court of India, eligible Employees/Exemployees and his/her employer are required to submit a Joint Option under erstwhile Para 11 (3) & Para 11 (4) of the EPS'95 within a period of 4 month from the date of judgement.

Since no format for the Joint Option has been provided by EPFO (also not available on EPFO's website), based on similar formats issued by various ROs/EPFO in the year 2021 & 2018 while implementing the RC Gupta Judgment; in order to comply with the above requirement, we (Employee/ Ex-employee and Employer) are hereby submitting the Joint Option Form as required under erstwhile Para 11(3) & Para 11(4) of EPS – 1995, for claiming pension on actual salary instead of ceiling fixed from time under the EPF Act.1952.
